1. The class/section/subject wise number of students mentioned by you in the reference proposal in your college should be actually on the fold.

2. The hours specified for Lectures / Demonstrations / Tutorials (Lesson Guidance) Project Work (Project Work) should be as per the rules prescribed by UGC, University and Govt.

3. A batch of at least 15 to 20 for first year to third year science class for demonstration.

4. The subject wise hours shown must actually be in the timetable. Assistant/Associate Professors whose workload is less than 12 hours and whose workload is up to 18/20 hours will be reduced to Junior / Unaided / Overload of the subject in the same class is necessary.

5. Appointments to the said post should be made through this advertisement of the committee constituted as per the prevailing and university constitution and also in accordance with all related rules of the government.

6. The minimum number of students of the subject / batch should be as per prevailing rules prescribed by the government from time to time.

7. Government orders regarding all relevant subjects/batch approved and eligible batches. It is essential to have access to the college.

8. In the next academic year, due to reduction in the number of students and other reasons, the number of teacher posts will be reduced accordingly.

Government decision dt. 13/02/2000 and dt. As per 16/06/2000 recruitment of open category candidates who have not passed (NET/SET) examination and also without merit list is prohibited. Such assignments will be calculated on hourly basis. A teacher on hourly basis should not be paid more than 11 hours per hour. Our college is being sanctioned subject to the approval given by the government to start it permanently on a non-subsidy basis. Therefore, the salary and allowances related to the appointment on the said post and its full financial responsibility will remain with the college / institution.
